## NOTIFICATION

This is for information to all concerned that a student who is willing to change his/her disciplines, may change the same as per the following norms under Clause No. 2.4.1 and 2.4.2 of Academic Bye-Laws. (U. G Programme).

### 2.4.1 AT CERTIFICATE LEVEL:

- A student may be allowed to change his/her discipline at the end of the 1<sup>st</sup> year in the Certificate Module, if vacancies exist in the desired discipline provided that he/she secures a CGPA of 9.50 or more out of 10.0. If there is a tie, the marks obtained in NEE-I will be considered to decide the ranking of the student. The marks obtained in Mathematics/Physics/Chemistry in that order, in NEE-I may also be considered to break the tie, if needed.
- Not more than two students from a discipline shall be permitted to change over to other disciplines in one session.
- The change of discipline as above is not permitted to those who have withdrawn from a semester or availed make-up test or supplementary examination.

### 2.4.2 AT DEGREE LEVEL (to CS only):

A total of 11 seats are available in Computer Science and Engineering at Degree level for vertical mobility. NERIST Certificate holders may opt to join Computer Science and Engineering on merit decided by the CGPA and as per the following quota:

PRC holder – 1, State quota – 8 (one for each NE states), All India – 1 (one) and EWS-I (Total – 11 seats).

On selection the students may take admission (vertically) in Degree Module in Computer Science and Engineering. Interested students may apply in prescribed format as attached and may submit the same to the Academic Section by hand or through email ([dracad@nerist.ac.in](mailto:dracad@nerist.ac.in)) on or before **07.07.2023**
