- 1. Submission of hard copy of prescribed application in format (Annexure-I) with Annexures with details as per AICTE/UGC regulation as applicable are required for the post of Professor or Associate Professor.
- 2. Incomplete applications and/or applications received after the due date shall summarily be rejected and no further correspondence in this matter shall be entertained;
- 3. Vacancies are tentative and may increase or decrease:
- 4. The pay bands carry other allowances admissible as per Government of India rules;
- 5. Institute reserves the right to fill or not to fill any or all of the vacancies advertised;
- Applications received in response to the advertisement will be scrutinized; and short-listed candidates only
  will be called for interview. Mere fulfillment of minimum eligibility criteria laid down in the advertisement
