The programs have been granted accreditation for further 3 years. **North Eastern Regional Institute of Science and Technology, Nirjuli, Itanagar, Arunachal Pradesh- 791109** should submit fresh online application under Tier I SAR January 2016 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
